Eligibility:

Subject to the provisions of Section 20 (10) and Section 65 (1) (a - c) of the Cooperative Societies Act, Cap. 107, and the SACCO's Byelaws, an applicant for leadership of the SACCO **MUST**:

- 1) Be a natural person.
- 2) Be at least eighteen years in age.
- 3) Be an active, registered member of the SACCO in good standing.
- 4) Not be receiving any remuneration, salary or other payments from the SACCO which has not been lawfully approved by resolution of the General Meeting.
- 5) Not be in a business competing with the SACCO.
- 6) Not be an undischarged bankrupt.
- 7) Not be of unsound mind, or has been declared to be of unsound mind by any court of law in Uganda or elsewhere.
- 8) Not have been convicted in court of any offence involving embezzlement, dishonesty or violence.

- 9) Not be a dismissed employee of any cooperative society.
- 10) Not have committed any act that may reflect negatively on the reputation of the SACCO.
- 11) Not have been removed from the Board of a society by the Registrar as provided in the Cooperative Societies Act.
- 12) Not be having a loan or is a guarantor of a loan whose repayment or any instalment thereof has exceeded the due date by more than 30 days.
- 13) Hold a Uganda Certificate of Education or its equivalent.
- 14) Hold the minimum number of shares prescribed by the General Meeting of members (250 shares for Board Chairperson, Vice Chairperson and Treasurer, and 170 shares for other applicants).
- 15) Not be of blood relations with another person on the same Board up to the second degree; a second degree relationship means a grandchild, grandmother or grandfather.
- 16) Not be in a marriage relationship with any of the SACCO's employees.
- 17) Not be a joint account holder.
- 18) Not be part of a Board which has failed to prepare accounts within the specified period as required by the Cooperative Societies Act.
- 19) Not be on any committee of another SACCO.
